Contactless Payments

Contactless payments, otherwise known as tap-and-go payments, refer to a secure method for consumers to purchase products or services using a debit, credit, smartcard, or another device such as smart phone or smart watch by using radio frequency identification (RFID) technology and near-field communication (NFC). Contactless payments are rapidly growing in popularity, especially in lieu of the ongoing pandemic because this offers an alternative to pay while having minimal to no contact with the payment terminal. It works by bringing either your phone or contactless capable card near the contactless symbol on the terminal. Information is transmitted between devices, and will give an indication when the payment has been accepted. Citizens State Bank now offers contactless payments on Credit Cards! Look for the sideways Wi-Fi symbol to know if your card has these capabilities!

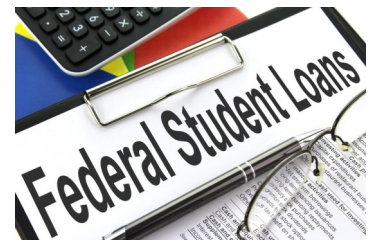

Automatic Temporary 0% Interest and Administrative Forbearance as a Result of the COVID-19 Emergency. To provide relief to student loan borrowers during the COVID-19 emergency, interest is being temporarily set at 0% on **federal student loans**.
